Highlights of Recent BSI Webinars



1 Oct 2024

Tan Chin Hong, Assistant Professor of Psychology at NTU, presented a webinar titled "Biopsychosocial Determinants of Neurocognitive Health". He discussed the need to go beyond biological factors to examine empirical findings on the role of psychosocial factors in the prediction and prevention of Alzheimer's disease.



22 Oct 2024

Tsai Ming-Hong, Associate Professor of Psychology at SMU, presented a webinar titled "Can conflict improve organizational commitment and reduce turnover intention?". He discussed the theoretical arguments and empirical findings on the potential positive and negative effects that different types of task conflicts may have on work attitudes.



5 Nov 2024

Kimin Eom, Senior Lecturer at Australian National University presented a webinar titled "Consumer responses to scientific consensus: The moderating role of perceived motives of scientists". He discussed how the positive effect that scientific consensus has on the perception of safety of cultured meat may be moderated by the perceived motives of the scientists.

Insights and Applications from Behavioural Sciences

In the third "Insights from the Inside" engagement session (organised by the Social Science Research Council) held on 29 Oct and attended by faculty from NUS, NTU, SMU, SUTD, and SUSS, BSI Director Professor Chan shared his personal career journey first as a police officer and subsequently in academia, and how practical life experiences have shaped his worldviews and belief in a scientistpractitioner model approach to issues in research, practice and public policy. He also offered advice on effective collaborations with public agencies, stressing the importance of professional engagements, social interactions and networks, and building trust in competence, integrity and benevolence as they relate to one's credibility with the research community, agencies and the public.
